In Continuation to the earlier instructions issued vide reference (6) cited above, the following further guidelines are issued regarding the 6 months mandatory Internship/ Apprenticeship/On the Job Training to be taken up 5th/6th Semesters.

As per the guidelines on Revised CBCS 2020-21, every student has to complete 10 month mandatory internships i.e., 2 months of CSP after I year, 2-month internship after II year and 6-month internship during III year. It is ideal if the student can pursue both 2-month Internship and 6 months internship in the same Industry. If any industry is not willing to continue the 6-month internship, then the Principal of Government Degree College is informed to approach respective District Collectors seeking allotment of the 6-month Internships in another industry.

In this connection, the Principals of the GDCs have been requested, vide reference cited (7), to submit data in "Add Internships Details" web form which is

available in College Admin Panel at http://apcce.gov.in/TSEHome regarding continuation of 6 month internship.

Further, the Principals of Government Degree Colleges are instructed to follow the guidelines given by respective affiliated universities on the implementation of 6-month Internship. It is also instructed to ensure that all students belonging to the same class in a GDC should undergo 6-Month Internship training in the same semester i.e., in 5th Semester or 6th Semester at the same time. Splitting of class between different semesters is not acceptable. Moreover, all students should mandatorily undergo 6-month Internship training in Physical mode only. Any deviation in the matter would be viewed seriously.
